8. Resolution to remove the Inspector-General of Police, Mr. T.M.W. Deshabandu Tennakoon from the office of the Inspector-General of Police in terms of Section 17 of the Removal of Officers (Procedure) Act, No. 5 of 2002,— The Speaker moved,— Whereas the Parliament on the 08th of April, 2025 passed the Resolution No. P. 29/2025 appeared in the Order Paper of Parliament dated 08.04.2025 and a Committee of Inquiry (hereinafter referred to as the "Committee") was appointed under Section 5(2) and Section 6(b) of the Removal of Officers (Procedure) Act, No. 5 of 2002, to inquire and report its findings in respect of the allegations in the said Resolution;

whereas in terms of Section 8(1)(b) of the said Act, the Committee had made its findings and communicated such findings to the Speaker on 21.07.2025;

whereas the Report of the Committee containing its findings has been tabled before the House by the Speaker on 22.07.2025;

This Parliament resolves, under Article 41C(3) of the Constitution of the Democratic Socialist Republic of Sri Lanka read with Section 18 of the Removal of Officers (Procedure) Act, No 5 of 2002, that the Inspector General of Police, Mr. T. M. W. Deshabandu Tennakoon, based on the findings of guilt recorded by the Committee of Inquiry and the said Report tabled before this House, be removed from office of the Inspector-General of Police.
