### **QUESTIONS FOR ORAL ANSWERS**

Hon. Sivagnanam Shritharan,—To ask the Minister of Trade, Commerce, Food Security and Cooperative Development,—(1)

- (a) Will he inform this House
  - (i) whether he is aware that the building which houses the Sathosa store in the center of Kilinochchi town was constructed without a proper approval;
  - (ii) whether relevant approval for the construction has been duly obtained from the Karaichchi Pradeshiya Sabha;
  - (iii) of the details of the quotations called for it, if the public funds have been spent on the construction of the building;
  - (iv) of the amount spent on the construction, in millions of rupees; and
  - (v) of the current owner of the aforesaid building?
- (b) Will he also inform this House
  - (i) of the institution that owns the land on which the building is located; and
  - (ii) whether the land concerned has been given to any party on longterm lease basis?
- (c) If not, why?

- (ii) whether he accepts that the said personnel have gone abroad owing to the economic crisis that prevailed during the previous government, and they are currently remitting a large amount of foreign exchange to Sri Lanka by engaging in various jobs;
- (iii) whether he is aware that they are arrested upon their return to Sri Lanka since they have not legally left the military service;
- (iv) of the action that are taken against the personnel of the Tri- Forces who are arrested; and
- (v) whether arrangements will be made to minimize the time taken for their lawful discharge from the military service?

  - (ii) whether a fair and systematic methodology will be followed regarding them;
